What is Group PT?

The Group PT team is busy enrolling sites for our first cohort! If you have read our newsletter before, you may have seen the benefits of implementing this program as part of Function QUERI:








- Group PT is an efficient model requiring fewer clinical hours per patient.
- Sites will receive tools and resources to support implementation of Group PT.
- The program can be adapted to fit local needs.

However, you may still be wondering, exactly what is Group PT? Here's the scoop:

This program targets patients with **knee osteoarthritis**. Patients can be referred from a treating provider or via self referral. The physical therapist receiving the consult will review the patient's medical history to confirm the patient is appropriate and then set up an **initial evaluation** to determine strength and functional status of the patient. After that, the patient can be scheduled for the first Group PT class! There are **six classes** in a full Group PT session. Each class includes the following components:




Frequently asked question:

- 1. Can a physical therapy assistant or kinesiotherapist lead the class? Yes!
- 2. Do we provide guidance on the exercise series for patients? Yes!
- 3. Do we provide CPRS notes for capturing data from the initial evaluation and Group PT class? Yes!
- 4. If my site participates, how quickly do we need to lead a class? We expect your site will lead at least one Group PT session (6 classes) within the first 6 months of participation.

Does STRIDE Impact Disparities in Hospitalization Outcomes?

Function QUERI is thrilled to announce that Sarah Wilson, PhD won a QUERI Initiative initiative to Advance Diversity in Implementation Leadership (ADIL) award to work with our STRIDE inpatient mobility program. For the next two years, Dr. Wilson will be quantifying disparities in hospitalization outcomes prior to implementation of STRIDE, disparities in Veteran access to the program, and staff fidelity of the program.





STRIDE Continues Expansion

Function QUERI is continuing active enrollment of VA facilities interested in launching a STRIDE program in the acute care setting. We have enrolled 15 VA Medical Centers since June 2021 and we are looking to expand our network by enrolling more facilities!

Caregivers FIRST Data Dashboard



In partnership with the VA Caregiver Support Program (CSP) as part of the national minimum standard, Caregivers FIRST sites now have access to a data dashboard that provides a summary of key implementation activities. Sites and CSP VISN leads can now access number of caregivers referred, enrolled, and trained as part of the program.

Function QUERI would like to thank **Kate Lewis**, Health System Specialist with CSP for leading the effort. So far, the dashboard reports approximately **750 caregivers trained** nationally with Caregivers FIRST since October 2021! Caregivers FIRST sites can access the Dashboard via our <u>SharePoint</u> page.

Caregivers FIRST Begins Study Cohort!

Function QUERI recently published an article looking at how clinical staff's understanding about roles in promoting inpatient mobility evolved during implementation of the STRIDE.
